- Determine procedures aimed at verifying that the HACCP Method is working correctly
- Determine the documents regarding all the procedures and all the data to be saved, which must be adequate to the present principles and their application.

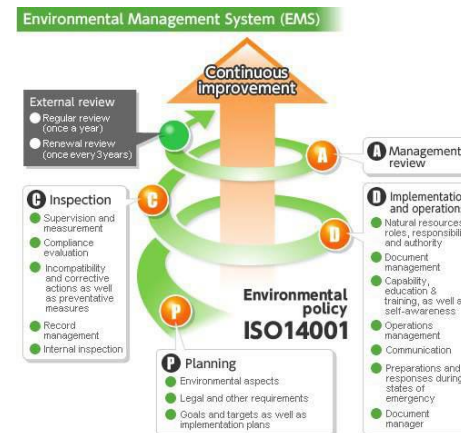

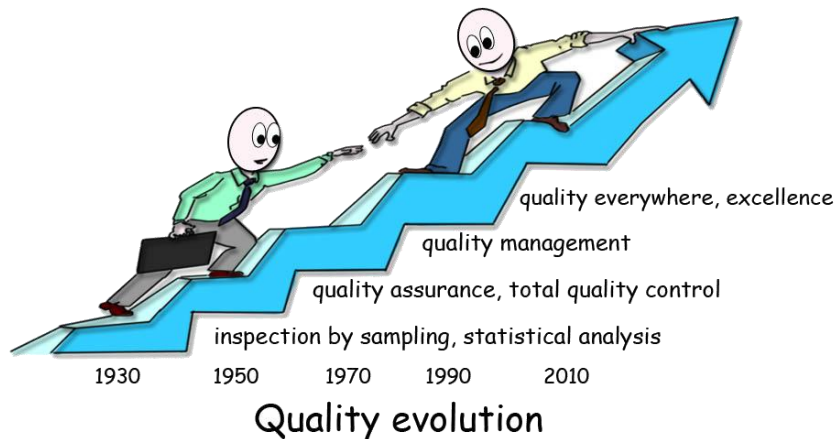

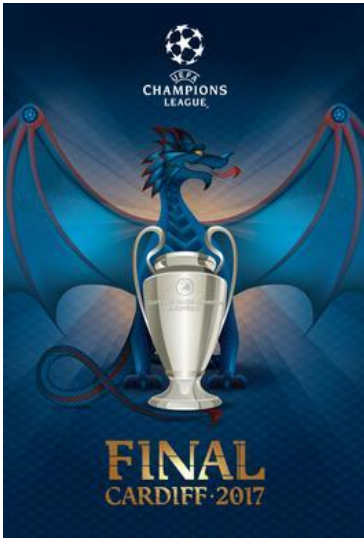
What the new EU GDPR means in 1 minute
