

INFORMATION FOR THE PROCESSING OF PERSONAL DATA (regulation (EU) 2016/679 of the European Parliament and the Council of 26 April 2016)

hereby, Framinia s.r.l. based in Rome, Via Paolo Emilio 34 - 00192, as Data Controller (hereinafter also the "Company"), informs you - in compliance with the regulation (EU) 2016/679 of the European Parliament and the Board of 26 April 2016 concerning the protection of personal data (hereafter "GDPR") - regarding the use of your personal data that you provide by registering for the training course chosen by you among those organized by the Company.

Therefore, pursuant to art. 13 of the GDPR, we wish to provide you with the following information:

- 1. the processing of your data will be carried out in compliance with the principles of correctness, lawfulness and transparency and protection of your privacy and your rights, as required by art. 12 of the GDPR;
- 2. your data will be processed for the pursuit of the purposes related, instrumental and / or functional to the contractual relationship related to participation in the training course organized by the Company and will also cover the requirements related to the issue of participation certificate and the performance administrative, accounting, tax and legal activities:
- 3. your data could also be processed to perform profiling and direct marketing activities. The processing with these purposes will be carried out by means of similar methods (such as fax, e-mail), as well as traditional ones such as telephone calls with the operator; 4. the processing of your personal data will be carried out also for purposes related to the fulfillment of obligations under laws, regulations, community regulations, as well as orders and / or requests from public authorities;
- 5. your personal data will be made known to the staff of the Company who, appointed manager or processor in accordance with the current company organization, is responsible for their treatment in order to achieve the purposes previously indicated. Your personal data will not be disclosed to third parties and / or disseminated, except for the completion of the aforementioned purposes; these are third parties, appointed data processors, who may be in charge of outsourcing or third parties who perform functions strictly connected and instrumental to the Company's activities. Your personal data, without prejudice to compliance with the purposes of the processing as specified above, may be disclosed to parent companies or subsidiaries;
- 6. may also be appointed managers or agents, collaborators, consultants or persons in charge of services outside the Company for the operations indicated below: administrative services, civil-tax consultancy, for purposes related to the protection of the rights of the Company arising from contract, for other organizational purposes that the Company deems appropriate;
- 7. processing will also be carried out with the aid of electronic and / or automated tools, which can only be accessed by authorized subjects in full compliance with the law. The processing may include all operations or complex operations of collection, registration, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, deletion, destruction of data as required by the Privacy Code and necessary to the treatment in question;
- 8. regarding the security of personal data you provide, we inform you that they are protected from unauthorized access, use or disclosure and stored in a secure and controlled environment. If treated with the aid of electronic and / or automated tools, these will be suitable to guarantee the security and confidentiality of your data and can only be accessed by authorized subjects, in full compliance with the provisions of current legislation;
- 9. the provision of your data is essential for the conduct of the training course and, therefore, the refusal to provide data would make it impossible for him to participate in it.



The conferment of your personal data is optional for the purposes of profiling and marketing for which, therefore, you can express your specific consent to the processing;

- 10. Finally, we remind you that you can exercise your rights at any time, as Interested in processing, against the data controller, pursuant to art. 15 of the GDPR, as indicated below.
- 10.1. The interested party has the right to obtain confirmation of the existence or not of personal data concerning him, even if not yet registered, and their communication in intelligible form.
- 10.2. The interested party has the right to obtain the indication:
- a) of the origin of personal data;
- b) of the fin and treatment methods,
- c) the logic applied in the case of processing carried out with the aid of electronic instruments,
- d) the identification details of the data controller, data processors and the designated representative pursuant to article 2 of the GDPR;
- e) subjects or categories of subjects to whom personal data may be communicated or who may become aware of it as appointed representative in the territory of the State, managers or agents. 10.3. The interested party has the right to obtain: a) the updating, rectification or integration of data, b) the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those that are not necessary conservation in relation to the purposes for which the data were collected or subsequently processed c) the attestation that the operations referred to in letters a) and b) have been brought to the attention, including as regards their content, those to whom the data have been communicated or disseminated, except in the case in which this fulfillment proves impossible or involves a use of means manifestly disproportionate to the protected right. 10.4. The interested party has the right to object, in whole or in part: a) for legitimate reasons to the processing of personal data concerning him / her, even if pertinent to the purpose of collection; b) to the processing of personal data concerning him / her for purposes of sending advertising material or direct selling or for carrying out market research or commercial communication. As an interested party you can exercise your rights under art. 15 of the GDPR, above reported, according to the modalities contemplated in the art. 12 of the GDPR, in particular by sending a registered letter addressed to Framinia s.r.l., Via Paolo Emilio 34 - 00192, Rome.
